NEW BUSINESS

June Activity: Sunday June 8th – Cruise to Cape May. Terri Gregoretti reported that we will take the ferry over to Cape May, leaving cars at Lewes Terminal. Since we are leaving our cars at the terminal, you probably don't want to drive your Corvette. Cape May offers a short trolley tour which the group will take, and then we will have lunch at Henry's on the Beach. You will be on your own to tour Cape May and shop before we take the shuttle back to the ferry

and ride back to Lewes. Signup sheet will be available again at the next meeting. Total cost is \$23 per person which includes your ferry to and fro, shuttle to Cape May and Trolley tour. We will meet at the Magnolia Restaurant for breakfast at 7:30 am for those who choose, leave for Lewes at 8:30 for a 10:15 ferry – returning on the 6 pm ferry. **NOTE:** we changed this date from June 28th to June 8th for the opportunity to enjoy the Trolley Tour which does not run after the 14th and the weather should be more agreeable earlier.

July Activity: G Gregoretti and Bruce Ballard are planning an **Autocross** on Sunday July 13th at the Blue Hen Mall parking lot. The Autocross will entail cars driving through pylons that have been placed in weaving patterns, tight circles, and other configurations. This will be a timed event and each participant will get three runs at the course. The parking lot at the south-east corner of the Mall is a fairly new section and should be a nice location for the course. We have permission from the Mall management and coverage by our insurance provided. Participant arrival will be at 9 am to cover any paperwork needed with runs starting at 10 am. G is recommending that anyone participating should wear a helmet for safety sake but this is not mandatory. G made a motion for \$150 budget to buy trophies for this event. Approved and passed.

September Activity: Due to gas prices and the length of the Grand Canyon of Pennsylvania trip, we are going to change to a different location. The total trip would have covered close to 800 miles.

On Sept 12, 13, and 14 we would like to cruise to Colonial Williamsburg, VA. We propose to leave at 8:30 am on Friday morning, go down the DelMarVa peninsula, stopping at a very interesting place in Onley, VA and then stopping for lunch right before the bridge-tunnel. We should arrive in

Williamsburg by 3-4 pm. There is a nice restaurant within walking distance of the hotel and prospects of a Comedy Club that evening. On Saturday we are considering a Harbor Cruise of 3 hours that will show you Jamestown from the river, Battleship Row in Norfolk, peek into the Chesapeake Bay and stop at an old fort for a 30 minutes walking stop. Coming back to the hotel, you would have the afternoon to tour Colonial Williamsburg, on your own, or go to any of the many sites in Williamsburg area. We would go to a Haunted Dinner Theater to round out Saturday. On Sunday we could go to a plantation on the James River for a 1 ½ hour guided tour before starting home.

October – Hot Air Balloon and Wine Festival: Terry and Jowana Lamb mentioned to the club about a festival they have attended in the past. This years will be October 17, 18, and 19th in Millwood, VA – over near Front Royal, on Route 50. It is approx. 3 ¼ hours away so overnight would be considered. They have night balloons that light up the sky and something called a Pumpkin Glow. We'll look into more information at the next meeting.
